## Limitations

- 1. The treatment has not been interfered with or damaged. In the event that the failure has followed such damage Ryedale Remedials Ltd reserves the right to charge the owner for any services regarding inspection and repair work.
- 2. The further outbreak of rot or infestation is from the original treated source,
- 3. This guarantee does not cover any timber fungal decay or infestation present other than those areas treated.
- 4. Ryedale Remedials Ltd accepts no liability for any loss or damage arising from their works beyond making good of the work in question i.e. Timber Treatment. For example to furniture or other timbers beyond the re-treatment of the affected areas. Please note that due to entomology of wood boring insects, retreatment will not be carried out during the residual insect life cycle.

## CONDITIONS OF GUARANTEE

- a. Any recommended additional works identified in the original report, or quotation, that were considered necessary for the treatment to remain effective after the contract, were incorporated within 12 weeks of the completion date. Thereafter the property has been kept in a dry and weatherproof condition to a good and proper state of maintenance, with adequate ventilation throughout the property ensuring internal timbers have remained dry.
- b. Photocopies are not acceptable and it is recommended that the original documentation be kept in a safe place.
- c. Payment of the Ryedale Remedials Ltd invoice has been made in full, within 28 days of submission of invoice.
- d. Non-payment will automatically render the guarantee null and void. The guarantee is automatically invalidated if a fraudulent, misleading or exaggerated claim is made.

The guarantee only covers for in-situ treated timber. Any new timberwork must be pre-treated timber to BS52568:Part 5, but is not covered under the terms of this guarantee.
