

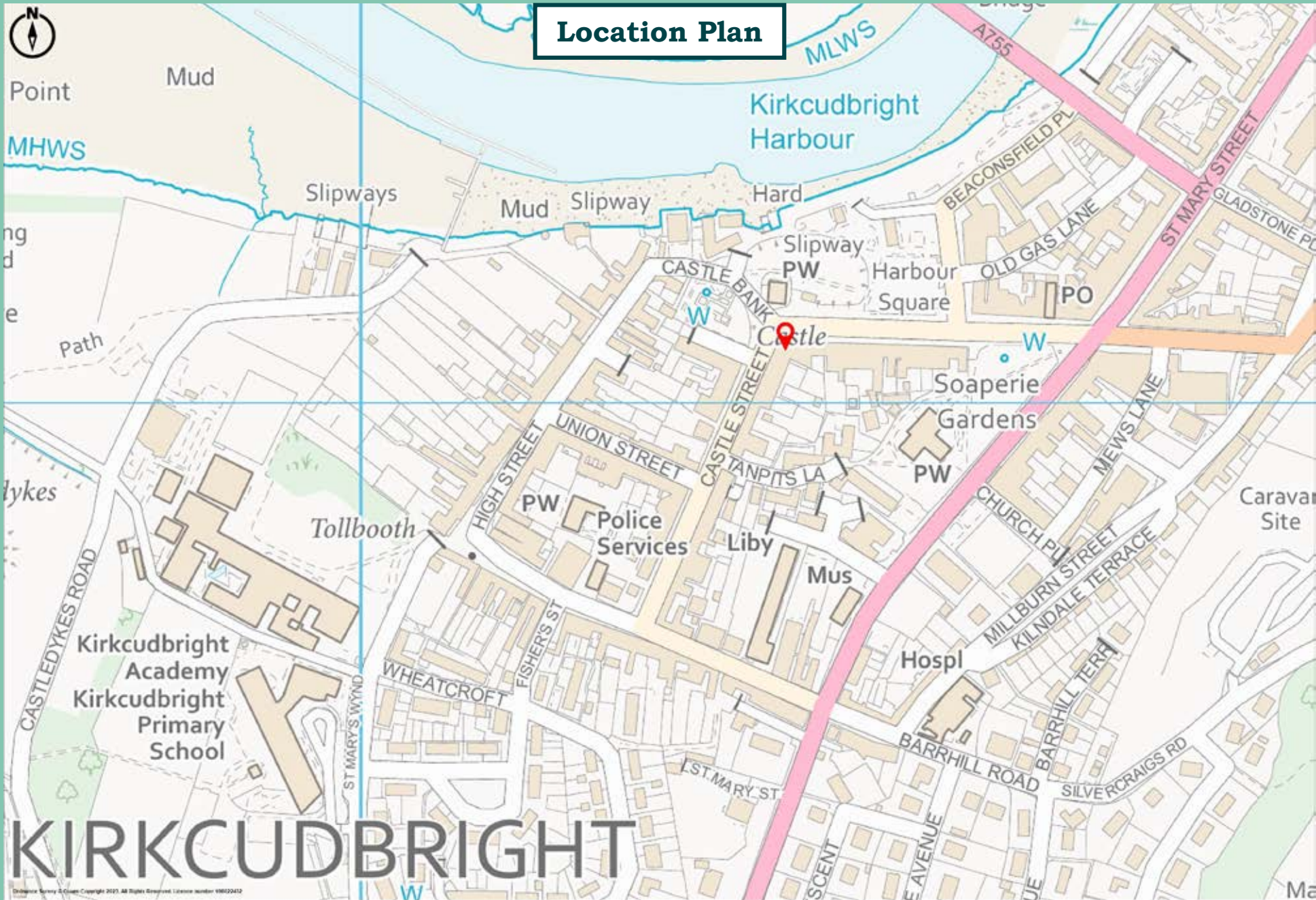

INTRODUCTION

No' 1 Castle Street is conveniently located within the 'Artist Town' of Kirkcudbright and some 10 miles southwest of the 'Food Town' of Castle Douglas in Southwest Scotland.

No' 1 Castle Street, a former successful hairdressing and beauty salon, is situated in a central location of Kirkcudbright where local amenities are available straight from the doorstep. The property was run as a commercial unit and still benefits from a rateable value, however, there could be some potential for conversion to residential to provide a charming living space over two floors, therefore, No' 1 Castle Street could appeal to a variety of buyers. The property has street frontage, however, there are no garden grounds. Any interested party wishing to pursue change of use should make their own enquiries with Dumfries & Galloway Council.

All essential services are found in the busy harbour town of Kirkcudbright, which is situated on the banks of the River Dee. Kirkcudbright is extremely popular with tourists and is known as the 'Artist's Town' as well as craft shops and niche retailers the town is well served with a full range of retail and professional services. Both primary and secondary schooling are available within the town, with both being highly regarded.

This area of Southwest Scotland enjoys one of the most varied and picturesque landscapes within Scotland, ranging from the moorland of the Southern Upland Hills to the bays and sandy beaches of the distinctive coastline. This is a rural county where agriculture and tourism thrive to form the backbone of the local economy. The area has been relatively unscathed by modern industry.

The region is well-known for the quality and variety of both field sports and leisure activities with the outdoor and sporting enthusiast extremely well-catered for as there exist the ability to take both shooting and fishing locally. Given the diverse landscape along with the proximity to the coast and local lochs, the area offers unique walks, sailing, cycling and for the golfer there is an abundance of good local courses with the region boasting no fewer than twenty-nine 18-hole courses, the closest being at Kirkcudbright. The Solway Firth is a popular yachting destination and Scotland's only 'Blue Flag' marina is located adjacent to Kirkcudbright Harbour.

No' 1 Castle Street is of traditional construction and set over two floors, briefly comprising:

- **Primary Shop Floor**

With the entrance from Castle Street, the main shop floor is a bright room with two large windows to the front. To the rear is a modern range of kitchen floor units with a sink and drainer set in. A staircase leads to the mid and lower levels of the building.

- **Mid-Level Landing**

Former beauty room with two large velux type windows and door to the side of the building.

- **Basement Accommodation**

One area is made up of a utility room with a cloakroom off. There is a further two rooms, one formerly utilised as an office with a storeroom off and the other utilised for general storage.

SERVICES

- Mains water and electricity
- Gas fired central heating
- The telephone line is installed subject to the normal BT regulations.
