INTRODUCTION

Toll Cottage is situated on the periphery of the picturesque market town of Castle Douglas. The property occupies a countryside location and is set within the boundaries of the National Trusts' Threave Estate network of wonderful walks and is within a short driving distance to all town centre amenities, the popular Fullarton Theatre and the pretty Carlingwark Loch.

Toll Cottage is of traditional construction benefitting from two-bedroom accommodation and generous, mature garden grounds which attract a variety of native wildlife on a daily basis. A useful detached timber garage and a brick built lean to shed off the cottage provides useful storage space. There is current planning permission in place for alterations and extension to the current footprint and any interested party can view this planning permission by visiting Dumfries & Galloway Council's planning portal using the reference: 22/2416/FUL

As mentioned earlier, local services are conveniently located only a short drive to the thriving High Street of Castle Douglas (The Food Town), which offers all essential services and is renowned for its niche retailing with a wide range of traditional shops, delicatessens, craft beer and wine outlets, butchers, bakers' grocers, craft outlets, etc. Both primary and secondary schools are also available within the town along with a modern health centre and a wide range of professional services, as well as two national supermarkets.

Communications to the area are good with the property lying in close proximity to the main A75 Euro Route, which provides quick access from the south via the M6 & M74. Cairnryan, the ferry link with Northern Ireland is a little over an hour's drive via the A75 and the international airports of Glasgow & Edinburgh within an easy drive of the property. There are mainline railway stations at both Dumfries and Lockerbie.

This area of Southwest Scotland enjoys one of the most varied and picturesque landscapes within Scotland, ranging from the moorland of the Southern Upland Hills to the bays and sandy beaches of the distinctive coastline. This is a rural county where agriculture and tourism thrive to form the backbone of the local economy. The area has been relatively unscathed by modern industry.

The region is well-known for the quality and variety of both field sports and leisure activities with the outdoor and sporting enthusiast extremely well-catered for as there exist the ability to take both shooting and fishing locally. Given the diverse landscape along with the proximity to the coast and local lochs, the area offers unique walks, sailing, cycling and for the golfer there is an abundance of good local courses with the region boasting no fewer than twenty-nine courses, the closest being within Castle Douglas.
