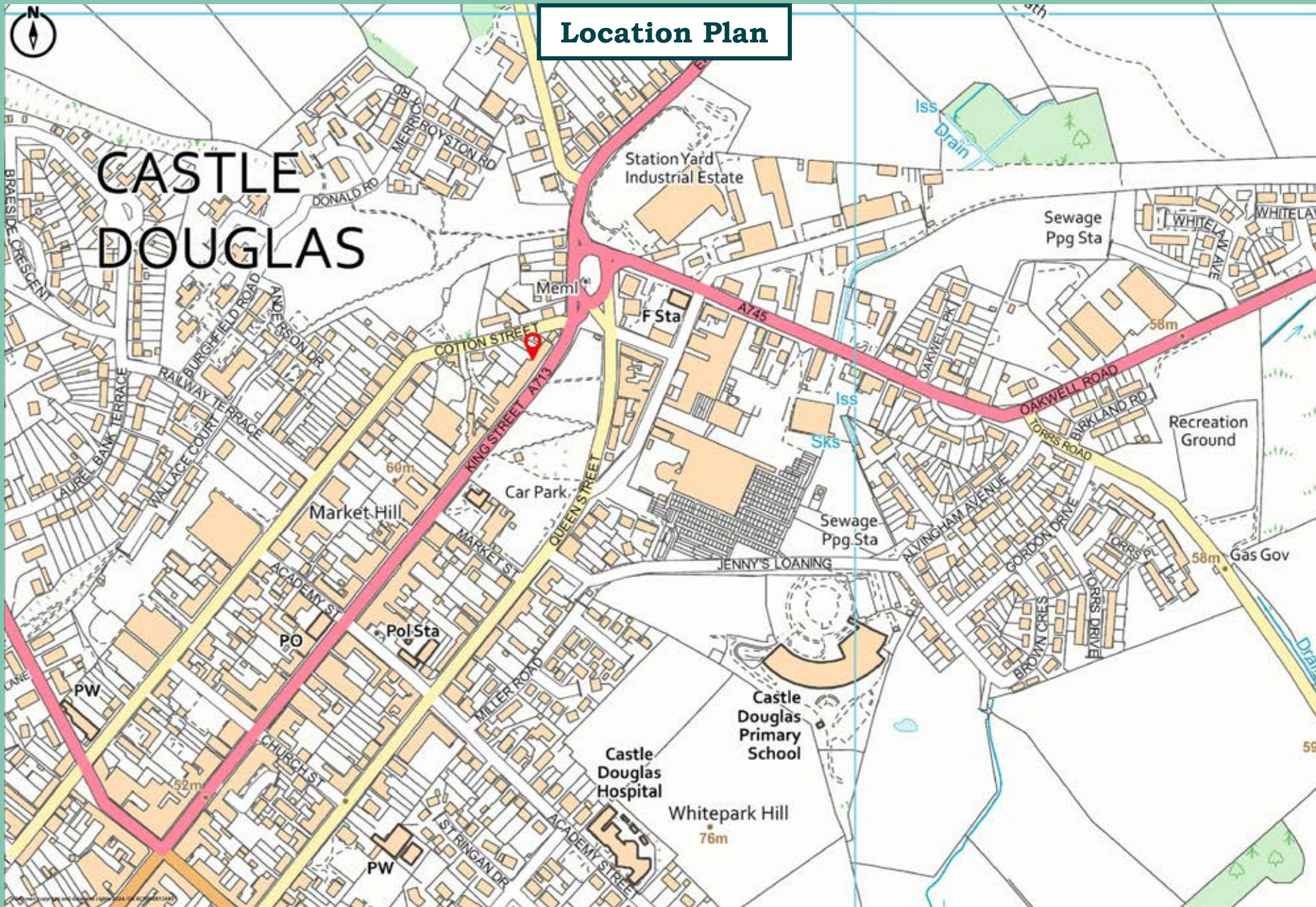

INTRODUCTION

No'10 King Street is situated within the bustling picturesque market town of Castle Douglas and conveniently located within a short walking distance to all town centre amenities.

No'10 King Street has been a wonderful family home for over 30 years and offers beautifully presented accommodation throughout, where attention to detail is second to none. The property has been extremely well-maintained and greatly improved within the current ownership presenting modern, clean lines throughout. Enclosed garden grounds to the rear are 3 tier gardens with laid patio to sunroom and useful storage area. In addition, a new WC and shower room has recently been installed within the rear garden grounds, making this a great place for showering off mucky dogs, boots, etc.

As mentioned earlier, local services are conveniently located only a short walk to the thriving High Street of Castle Douglas (The Food Town), which offers all essential services and is renowned for its niche retailing with a wide range of traditional shops, delicatessens, craft beer and wine outlets, butchers, baker's grocers, craft outlets, etc. Both primary and secondary schools are also available within the town along with a modern health centre and a wide range of professional services, as well as two national supermarkets.

Communications to the area are good with the property lying in close proximity to the main A75 Euro Route, which provides quick access from the south via the M6 & M74. Cairnryan, the ferry link with Northern Ireland is a little over an hour's drive via the A75 and the international airports of Glasgow & Edinburgh within an easy drive of the property. There are mainline railway stations at both Dumfries and Lockerbie.

This area of Southwest Scotland enjoys one of the most varied and picturesque landscapes within Scotland, ranging from the moorland of the Southern Upland Hills to the bays and sandy beaches of the distinctive coastline. This is a rural county where agriculture and tourism thrive to form the backbone of the local economy. The area has been relatively unscathed by modern industry.

The region is well-known for the quality and variety of both field sports and leisure activities with the outdoor and sporting enthusiast extremely well-catered for as there exist the ability to take both shooting and fishing locally. Given the diverse landscape along with the proximity to the coast and local lochs, the area offers unique walks, sailing, cycling and for the golfer there is an abundance of good local courses with the region boasting no fewer than twenty-nine courses, the closest being within Castle Douglas.

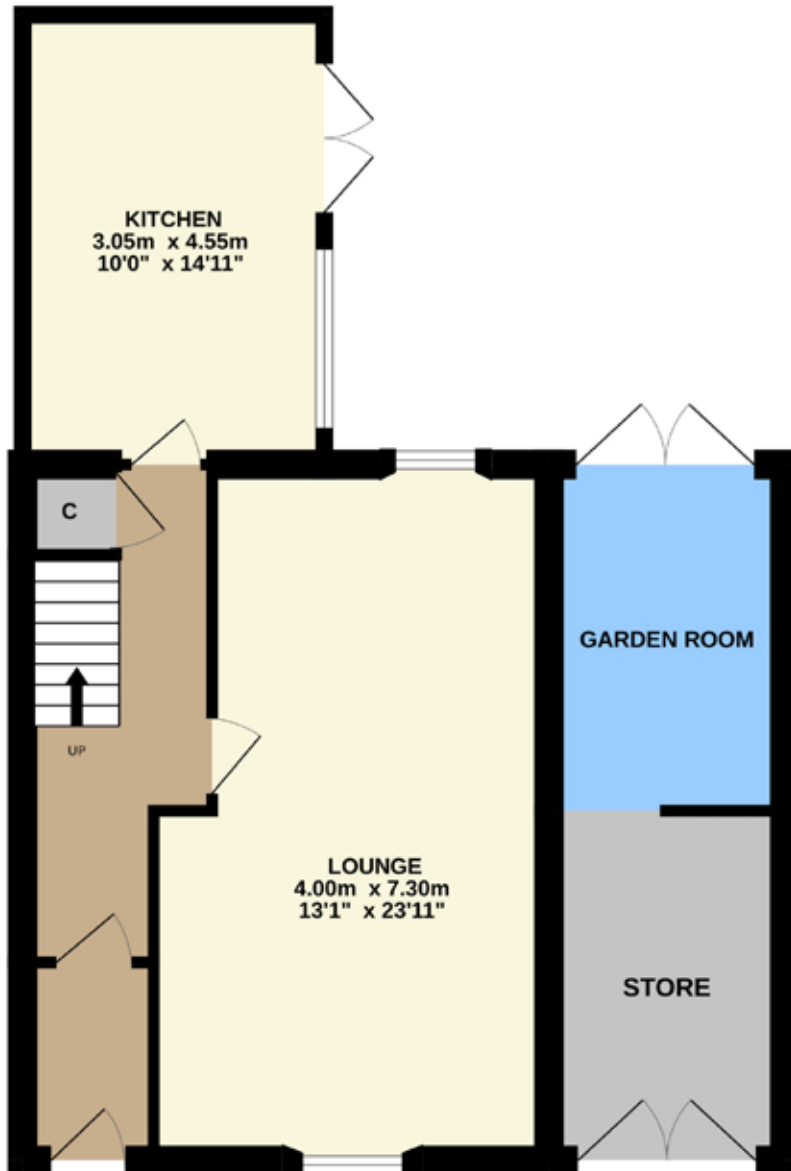

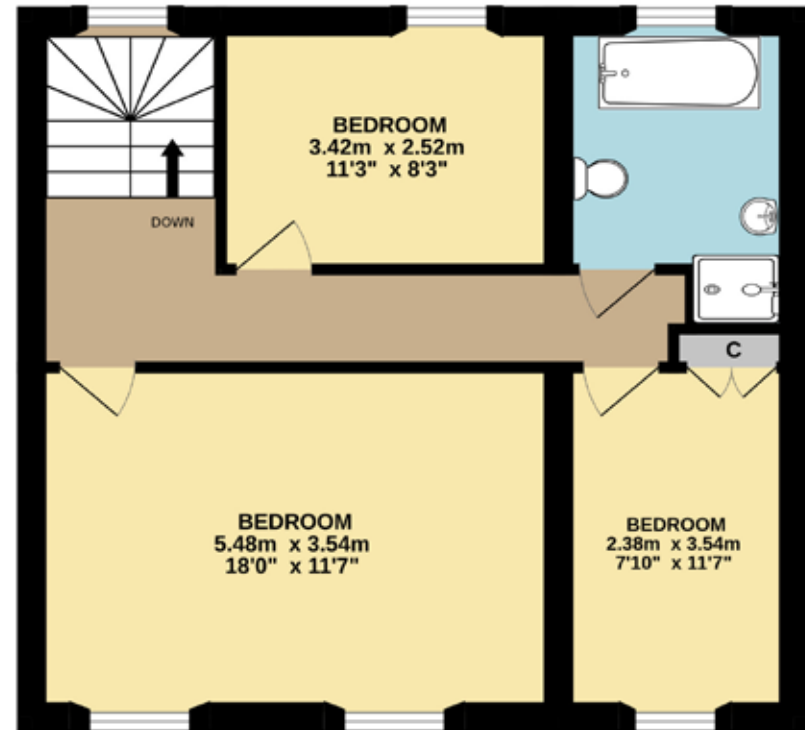


Floor Plan

- **Front Entrance Hallway**
Entrance hall with painted Rennie MacIntosh half glass door, with stairs up to the first floor and understairs storage cupboard.
- **Lounge / Diner**
The lounge area has a large picture window to the front overlooking the park and another to the rear overlooking the garden grounds. For those cosy nights there is a wood burning stove housed within a marble surround fireplace.
- **Kitchen**
The kitchen is fitted with a range of modern floor units, plumbed for white goods, free standing Belling gas hob & electric cooker with ample room for family dining. There are patio doors leading outside to a laid patio garden area.

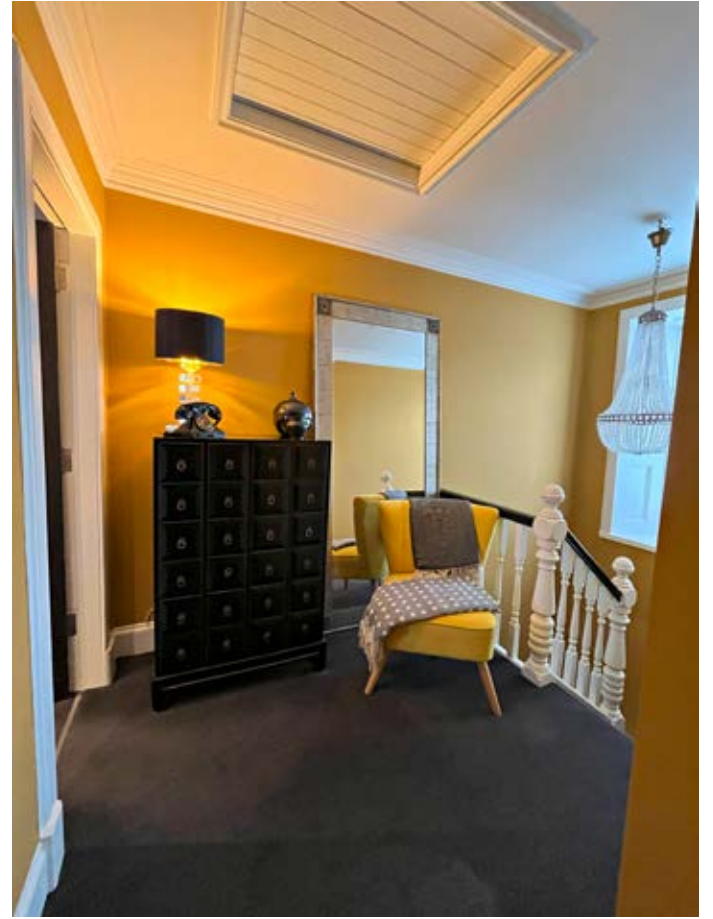

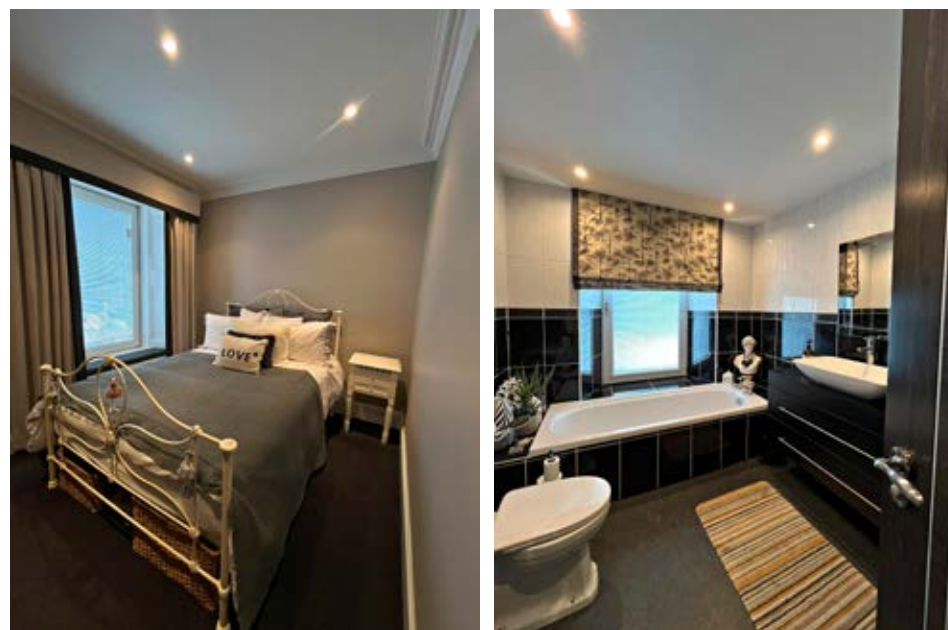
