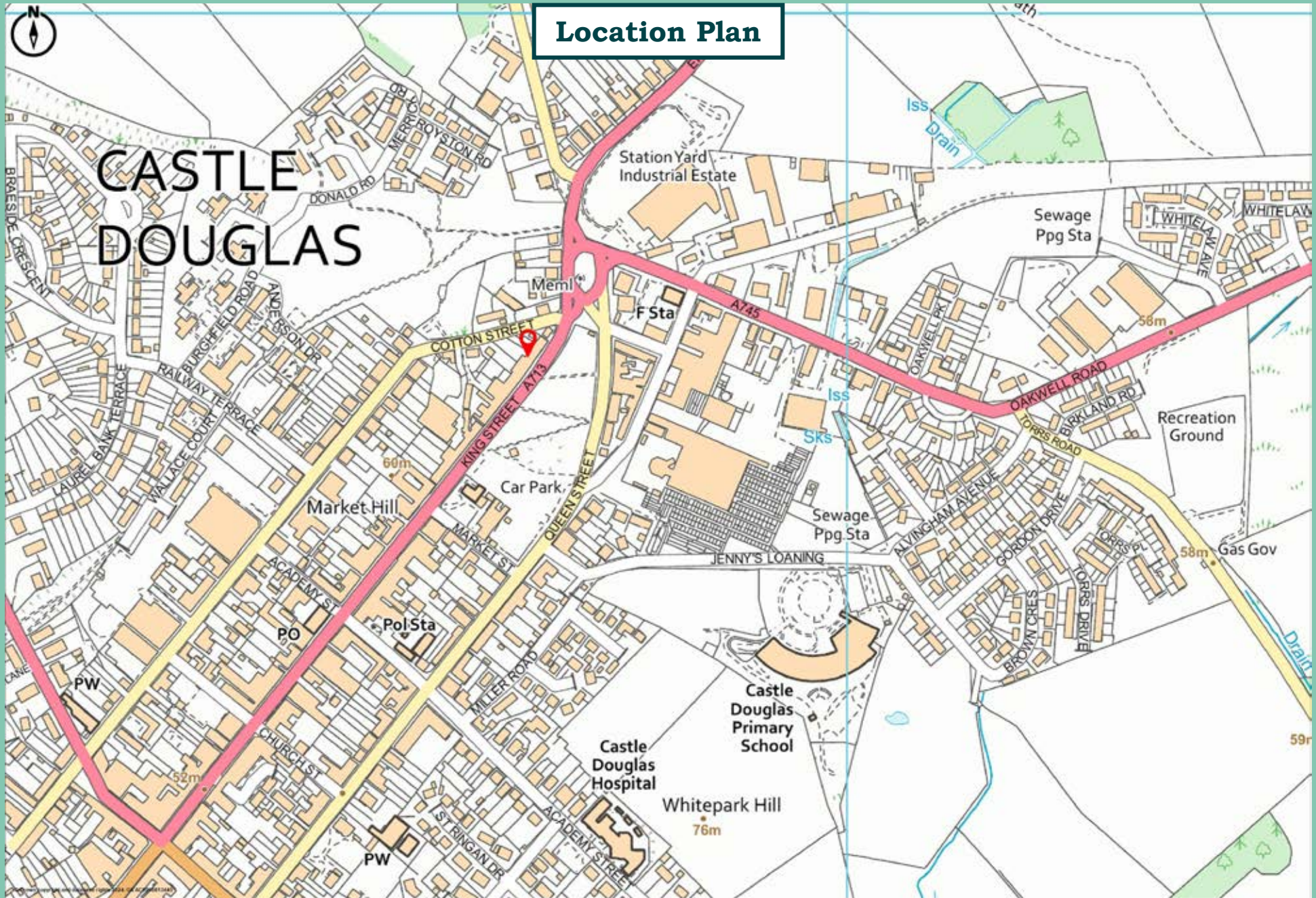

INTRODUCTION

Glenafton is situated within the bustling picturesque market town of Castle Douglas and conveniently located with town centre amenities available straight from the doorstep.

Glenafton is a wonderful family home offering bright, extremely well- presented accommodation throughout with the upper floors affording wonderful, elevated views across the rooftops towards the surrounding countryside. Enclosed south facing garden grounds to the rear offer a fabulous private space for alfresco dining and family or social entertaining, whilst providing a safe have for children and pets. A gate gives access to the double garage where at present is partly utilised for the owner's dog grooming business, but still providing enough space for one car and off-road parking available for another two.

As mentioned earlier, local services are conveniently located straight from the doorstep on to the thriving High Street of Castle Douglas (The Food Town), which offers all essential services and is renowned for its niche retailing with a wide range of traditional shops, delicatessens, craft beer and wine outlets, butchers, baker's grocers, craft outlets, etc. Both primary and secondary schools are also available within the town along with a modern health centre and a wide range of professional services, as well as two national supermarkets.

Communications to the area are good with the property lying in close proximity to the main A75 Euro Route, which provides quick access from the south via the M6 & M74. Cairnryan, the ferry link with Northern Ireland is a little over an hour's drive via the A75 and the international airports of Glasgow & Edinburgh within an easy drive of the property. There are mainline railway stations at both Dumfries and Lockerbie.

This area of Southwest Scotland enjoys one of the most varied and picturesque landscapes within Scotland, ranging from the moorland of the Southern Upland Hills to the bays and sandy beaches of the distinctive coastline. This is a rural county where agriculture and tourism thrive to form the backbone of the local economy. The area has been relatively unscathed by modern industry.

The region is well-known for the quality and variety of both field sports and leisure activities with the outdoor and sporting enthusiast extremely well-catered for as there exist the ability to take both shooting and fishing locally. Given the diverse landscape along with the proximity to the coast and local lochs, the area offers unique walks, sailing, cycling and for the golfer there is an abundance of good local courses with the region boasting no fewer than twenty-nine courses, the closest being within Castle Douglas.

Glenafton offers family accommodation over two floors, very briefly comprising:

GROUND FLOOR

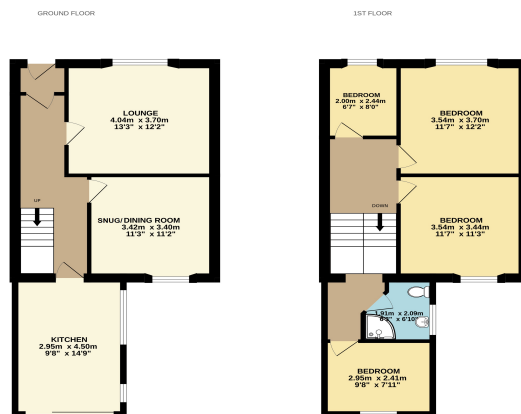
- **Front Entrance Porch**
With a modern composite door and part-stained glass door giving access to a bright and spacious central hallway.
- **Central Hallway**
With stairs up to the first floor and rather than understair storage, the owners have created a lovely reading area.
- **Lounge**
The lounge has a large picture window to the front overlooking the park and a gas fire is set in a lovely feature fireplace.
- **Sitting Room**
For those cosy nights there is a wood burning stove inset within a feature wall, a window to the rear overlooks the garden grounds.
- **Kitchen**
A lovely bright kitchen with patio doors to the enclosed garden grounds. The kitchen is fitted with a generous range of floor and wall units and is plumbed for white goods.

FIRST FLOOR

- Shower Room**
 From the mid-landing to the right, you step up to the shower room and single bedroom 1. The shower room benefits from a corner shower cubicle, heated towel rail, WC & WHB set in modern vanity unit.
- Small Double 1**
 Currently utilised as a craft room with a window to the rear affording lovely, elevated views across the rooftops, towards the surrounding countryside.
- Double Bedroom 2**
 Situated on the upper landing to the left, this bedroom has a built-in storage cupboard and a window to the rear.
- Double Bedroom 3**
 Another lovely bright room with a window to the front overlooking the park.
- Single Bedroom 4 / Study**
 With a window to the front.

OUTSIDE

As mentioned earlier, there are enclosed garden grounds to the rear with a paved patio and lawn, along with a garden storage shed. This area of the garden is bound by timber fences and a stone wall to one side. A gate gives access to the detached double garage to the rear where the current owners run a successful dog grooming business. The garage benefits from water and electricity and a WC, therefore could lend itself to a variety of different business uses.
